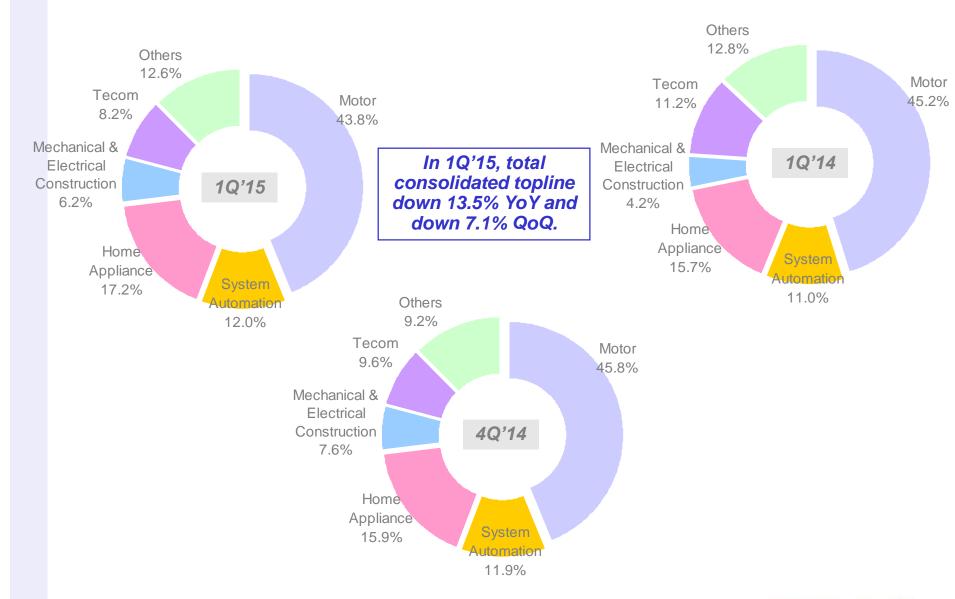

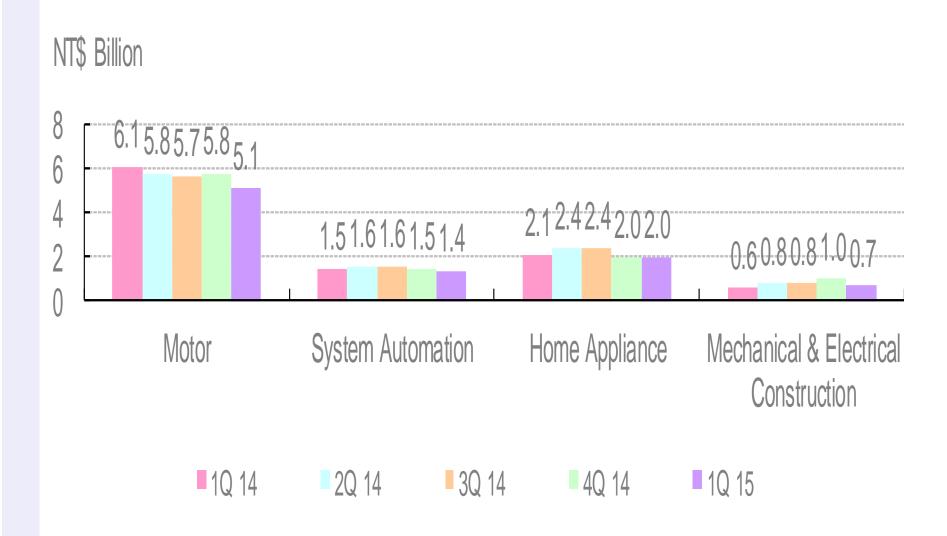


Revenue Breakdown

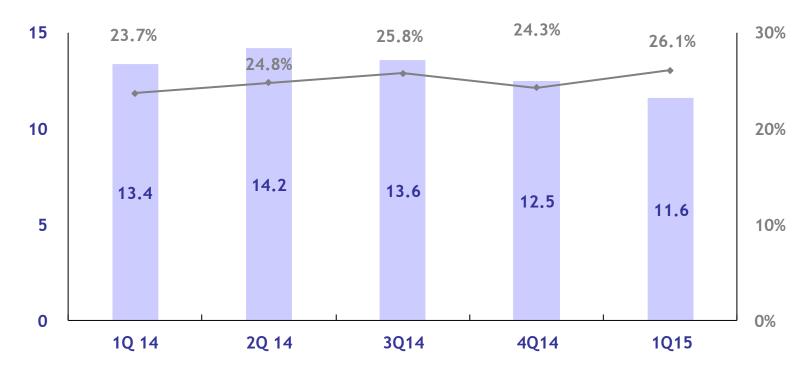

NT\$ Billion



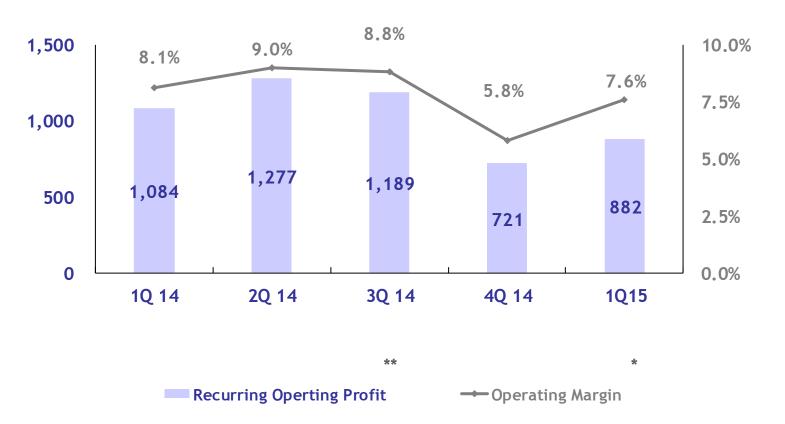
Recurring Operating Revenue*
