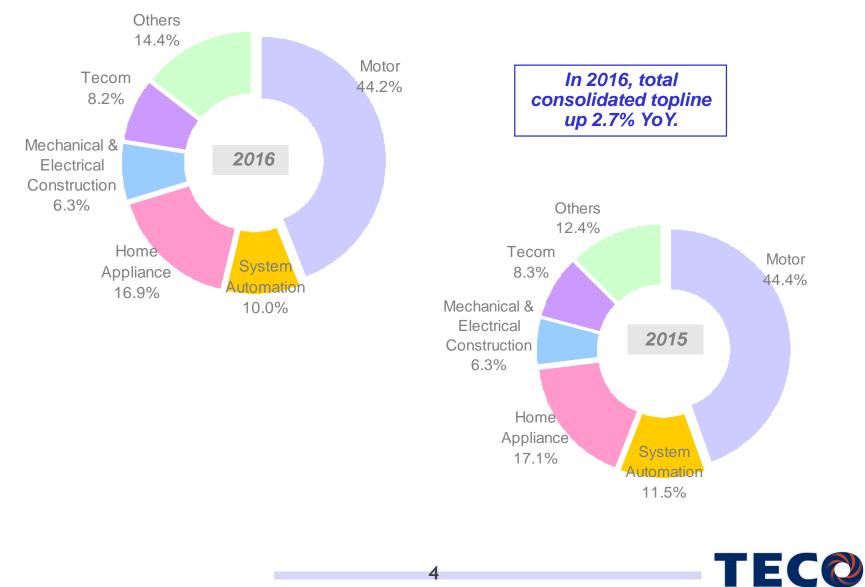

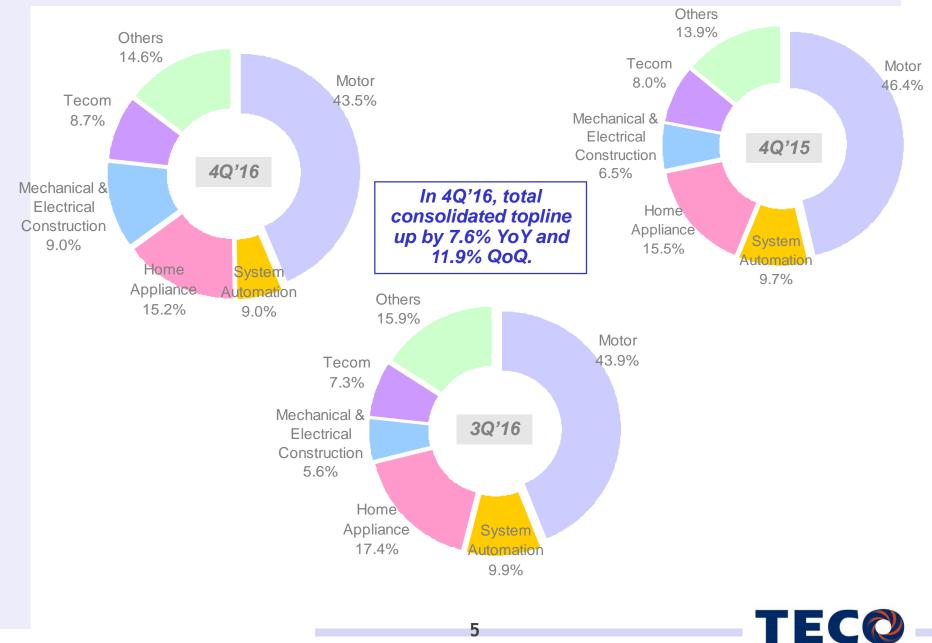


Revenue Breakdown 1/2



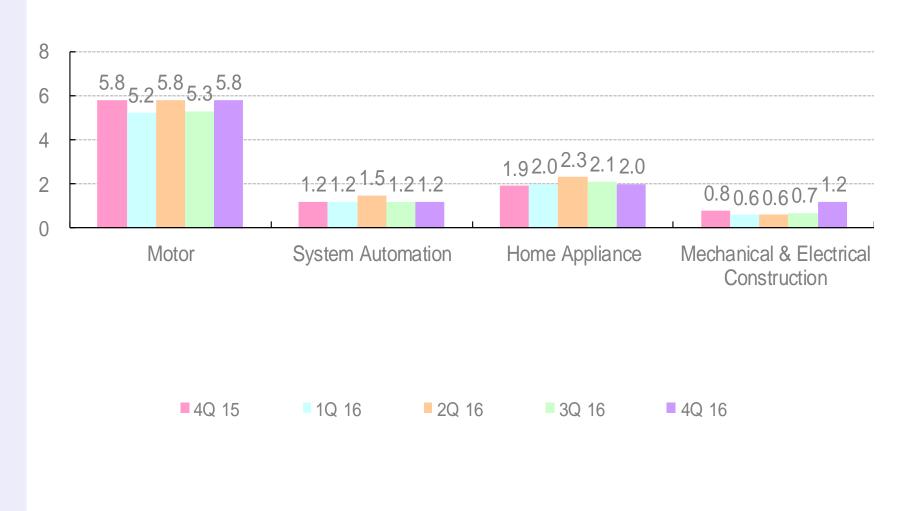

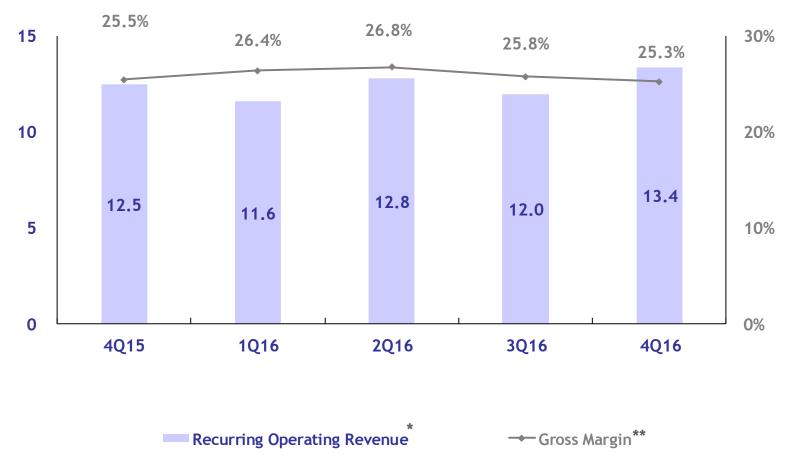

Recurring Operating Revenue vs. Gross Margin





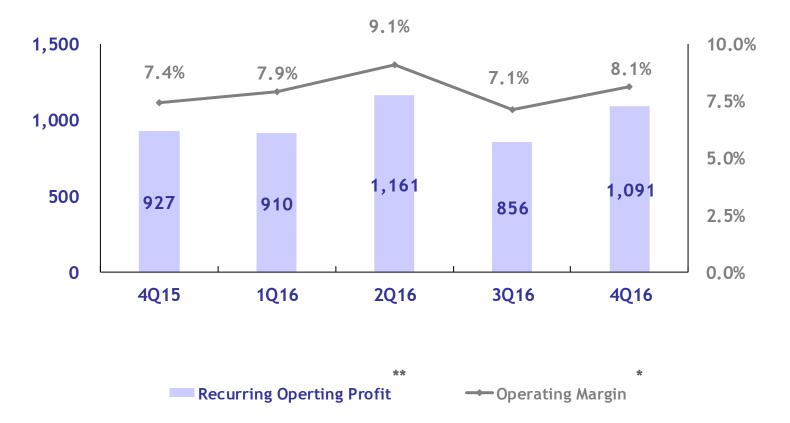
