Monthly Revenue Overview

The monthly consolidated revenue was NT\$ 4.87 billion for May 2024, down 4.64% YoY.

The cumulative revenue in year 2024 was NT\$ 23.38 billion, down 4.27% YoY, which was the second highest for the same period in the past 14 years.

Monthly Operating Performance by Business Groups

The monthly consolidated revenue was NT\$ 4.87 billion for May 2024, down 4.64% YoY. "Intelligence Energy" maintained growth, "Air & Intelligent Life" was roughly flat, "Green Mechatronic Solution" declined:

- Green Mechatronic Solution** : Revenue decreased compared to the same period last year, mainly due the decrease in VB Skid shipments in North America and the fact that demand in China has not yet recovered significantly.
- Air & Intelligent Life** : As the air-conditioning business grew, revenue from home delivery business decreased, resulting in revenue being approximately the same as the same period last year.
- Intelligence Energy** : Revenue contributions from projects related to offshore wind farms and Taipower's Power Grid Resilience Plan were the main sources of growth.

Cumulative Operating Performance by Business Groups

The cumulative revenue in year 2024 was NT\$ 23.38 billion, down 4.27% YoY. Both "Air & Intelligent Life" and "Intelligence Energy" were roughly flat, "Green Mechatronic Solution" declined:

1. **Green Mechatronic Solution** : Revenue decreased compared to the same period last year, mainly due to the sluggish demand in China and Europe.
2. **Air & Intelligent Life** : As the air-conditioning business grew, revenue from ITTS decreased, resulting in revenue being approximately the same as the same period last year.
3. **Intelligence Energy** : Mainly due to the gradual increase in engineering revenue recognized in Q2, the cumulative revenue in the first five months was approximately the same as the same period last year.
