Monthly Revenue Overview

The monthly consolidated revenue was NT\$ 4.97 billion for October 2025, up 17.08% YoY.

The cumulative revenue in year 2025 was NT\$ 48.73 billion, up 5.98% YoY, which was the second highest for the same period in the past 15 years.

Monthly Operating Performance by Business Groups

The monthly consolidated revenue was NT\$ 4.97 billion for October 2025, up 17.08% YoY. "Green Mechatronic Solution", "Intelligence Energy" and "Air & Intelligent Life" grew:

1. **Green Mechatronic Solution** : Revenue grew compared to the same period last year, mainly due to the recovering demand in the US and European markets.
2. **Intelligence Energy** : Revenue achieved double-digit growth compared to the same period last year, mainly due to the contribution from onshore substation projects of offshore wind farm and Taipower' s STATCOM engineering projects.
3. **Air & Intelligent Life** : The monthly revenue grew compared to the same period last year.

Cumulative Operating Performance by Business Groups

The cumulative revenue in year 2025 was NT\$ 48.73 billion, up 5.98% YoY. Both "Intelligence Energy" and "Air & Intelligent Life" grew, "Green Mechatronic Solution" slightly declined:

1. **Green Mechatronic Solution** : Revenue declined compared to the same period last year, mainly due to the impact of NT dollar appreciation and US tariff policy.
2. **Intelligence Energy** : Revenue increased compared to the same period last year, mainly due to the contribution from onshore substation projects of offshore wind farm and Taipower' s STATCOM engineering projects.
3. **Air & Intelligent Life** : Revenue increased compared to the same period last year, mainly due to the growth of air conditioning business.
