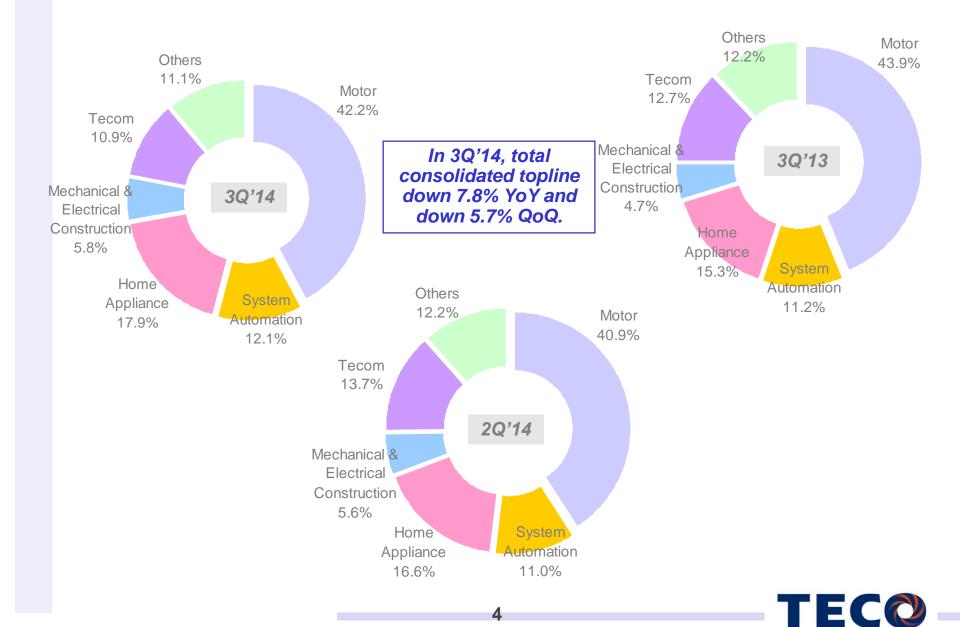

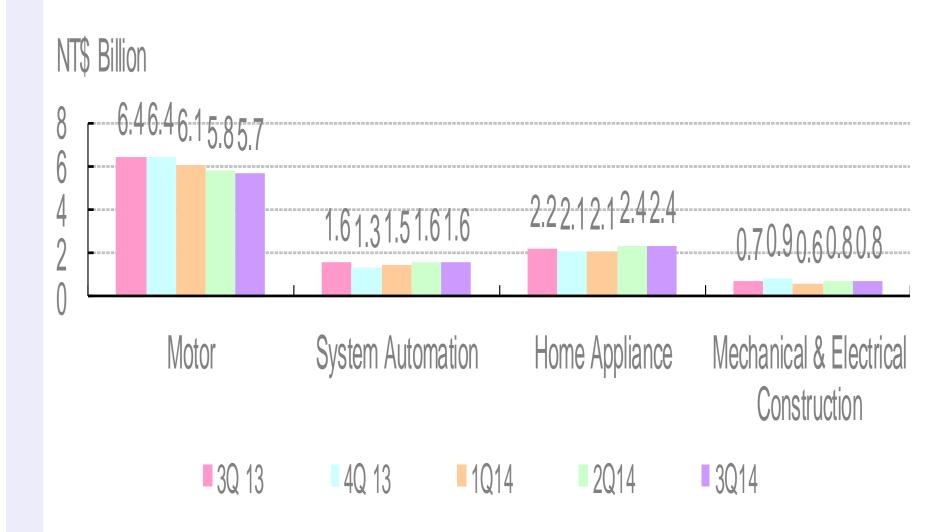

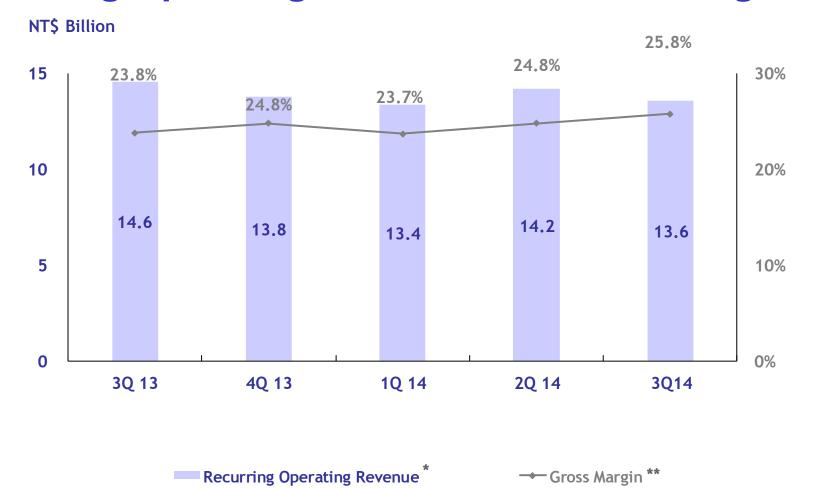

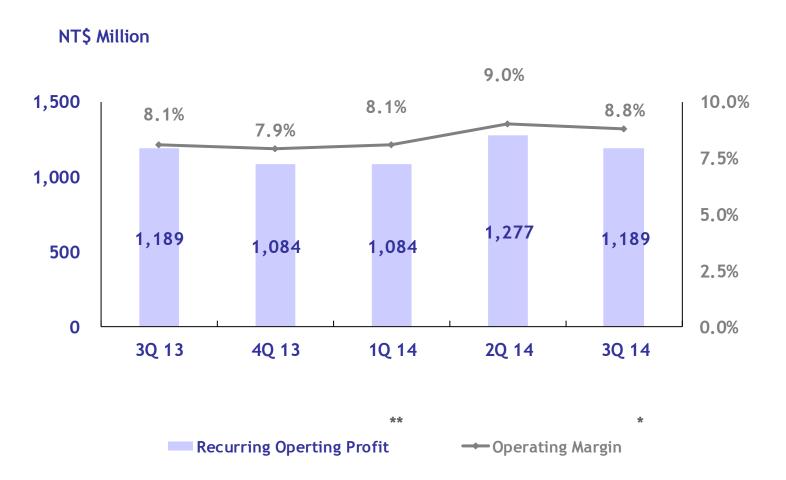
#### Recurring Operating Revenue vs. Gross Margin
