Monthly Revenue Overview

The monthly consolidated revenue was NT\$ 4.17 billion for February 2024, down 9.37% YoY, which was the second highest for the same period in the past 14 years. The cumulative revenue in year 2024 was NT\$ 9.08 billion, down 0.51% YoY, which was the second highest for the same period in the past 14 years.

Monthly Operating Performance by Business Groups

The monthly consolidated revenue was NT\$ 4.17 billion for February 2024, down 9.37% YoY. "Green Mechatronic Solution", "Air & Intelligent Life" and "Intelligence Energy" all declined:

- Green Mechatronic Solution** : Revenue decreased compared to the same period last year, mainly due to the Lunar New Year holiday in February, resulting in fewer working days.
- Air & Intelligent Life** : Revenue decreased compared to the same period last year, mainly due to the Lunar New Year holiday in February, resulting in fewer working days.
- Intelligence Energy** : Revenue decreased compared to the same period last year, mainly due to the Lunar New Year holiday in February, resulting in fewer working days.

Cumulative Operating Performance by Business Groups

The cumulative revenue in year 2024 was NT\$ 9.08 billion, down 0.51% YoY.

"Intelligence Energy" grew, "Air & Intelligent Life" was roughly flat, and "Green Mechatronic Solution" declined:

1. **Green Mechatronic Solution** : Revenue declined mainly due to factors such as the Israeli-Palestinian war and sluggish demand in Europe.
2. **Air & Intelligent Life** : The air conditioning business grew, however, due to the decrease in revenue of ITTS and TECOM, the business group's revenue was roughly flat compared to the same period last year.
3. **Intelligence Energy** : Revenue from substation projects of offshore wind farm was the main sources of growth.
