### Monthly Revenue Overview

The monthly consolidated revenue was NT\$ 4.45 billion for August 2024, down 10.91% YoY.

The cumulative revenue in year 2024 was NT\$ 37.36 billion, down 5.96% YoY.

### Monthly Operating Performance by Business Groups

The monthly consolidated revenue was NT\$ 4.45 billion for August 2024, down 10.91% YoY. "Green Mechatronic Solution" declined slightly, "Air & Intelligent Life" and "Intelligence Energy" declined:

1. **Green Mechatronic Solution** : Revenue decreased slightly compared to the same period last year, mainly due to the sluggish demand in North America.
2. **Air & Intelligent Life** : Mainly due to the decrease in revenue from TECOM, Taiwan Pelican and ITTS, the business group's revenue declined compared to the same period last year.
3. **Intelligence Energy** : Revenue decreased compared to the same period last year mainly because project-related revenue is recognized according to the progress of the project.

## Cumulative Operating Performance by Business Groups

The cumulative revenue in year 2024 was NT\$ 37.36 billion, down 5.96% YoY. "Air & Intelligent Life" declined slightly, "Intelligence Energy" and "Green Mechatronic Solution" declined:

1. **Green Mechatronic Solution** : Revenue decreased compared to the same period last year, mainly due to the sluggish demand in China, Europe and North America.
2. **Air & Intelligent Life** : Mainly due to the decrease in revenue from the air conditioning business and subsidiaries(TECOM, ITTS and Taiwan Pelican), the business group's revenue decreased slightly compared to the same period last year.
3. **Intelligence Energy** : Revenue decreased compared to the same period last year mainly because project-related revenue is recognized according to the progress of the project.
