Monthly Revenue Overview

The monthly consolidated revenue was NT\$ 5.27 billion for June 2025, up 8.70% YoY.

The cumulative revenue in year 2025 was NT\$ 29.01 billion, up 2.98% YoY, which was the second highest for the same period in the past 15 years.

Monthly Operating Performance by Business Groups

The monthly consolidated revenue was NT\$ 5.27 billion for June 2025, up 8.70% YoY. Both "Intelligence Energy" and "Air & Intelligent Life" grew, "Green Mechatronic Solution" was roughly flat:

1. **Green Mechatronic Solution** : The monthly revenue was roughly flat compared to the same period last year.
2. **Air & Intelligent Life** : Revenue increased compared to the same period last year, mainly due to the growth of air conditioning business.
3. **Intelligence Energy** : Revenue achieved strong double-digit growth compared to the same period last year, mainly due to the increase in revenue contribution from Taipower's STATCOM engineering projects.

Cumulative Operating Performance by Business Groups

The cumulative revenue in year 2025 was NT\$ 29.01 billion, up 2.98% YoY. Both "Intelligence Energy" and "Air & Intelligent Life" grew, "Green Mechatronic Solution" declined slightly:

1. **Green Mechatronic Solution** : Revenue declined slightly compared to the same period last year, mainly due to the sluggish demand in major markets.
2. **Air & Intelligent Life** : Revenue increased compared to the same period last year, mainly due to the growth of air conditioning business.
3. **Intelligence Energy** : Revenue increased compared to the same period last year, mainly due to the contribution of engineering project revenue.
