Monthly Revenue Overview

The monthly consolidated revenue was NT\$ 4.43 billion for February 2026, down 0.16% YoY.

Monthly Operating Performance by Business Groups

The monthly consolidated revenue was NT\$ 4.43 billion for February 2026, down 0.16% YoY. "Power & Energy" and "Energy & System Automation" grew, while "Green Mechatronic Solution" and "HVAC Technologies" declined:

- Green Mechatronic Solution** : Revenue declined compared to the same period last year, mainly due to the Lunar New Year holiday in February, resulting in fewer working days.
- Power & Energy** : Revenue achieved double-digit growth compared to the same period last year, mainly due to contributions from data center, offshore wind farm substation, and Taipower STATCOM-related projects.
- Energy & System Automation** : Revenue achieved double-digit growth compared to the same period last year.
- HVAC Technologies** : Revenue declined compared to the same period last year, mainly due to the downsizing of the home appliance business.

Cumulative Operating Performance by Business Groups

The cumulative revenue in year 2026 was NT\$ 9.07 billion, up 3.81% YoY. "Power & Energy", "Energy & System Automation" and "Green Mechatronic Solution" grew, while "HVAC Technologies" declined:

1. **Green Mechatronic Solution** : Revenue grew compared to the same period last year, mainly due to the growth in the European and Chinese markets.
2. **Power & Energy** : Revenue achieved double-digit growth compared to the same period last year, mainly due to contributions from data center, offshore wind farm substation, and Taipower STATCOM-related projects.
3. **Energy & System Automation** : Revenue grew compared to the same period last year.
4. **HVAC Technologies** : Revenue declined compared to the same period last year, mainly due to the downsizing of the home appliance business.


