As a result of carrying out verification procedures in accordance with ISO 14064-3:2006, it is the opinion of BSI with reasonable assurance that:

- The Greenhouse Gas Emissions with the TESEN Electronic Co., LTD. Kuang-In plant for the period from 2019-01-01 to 2019-12-31 is 19,310.286 tonnes of CO<sub>2</sub> equivalent, including scope 1 emissions 16,630.4669 tonnes of CO<sub>2</sub> equivalent and scope 2 emissions 2,679.8190 tonnes of CO<sub>2</sub> equivalent.
- No material misstatements for the period from 2019-01-01 to 2019-12-31 Greenhouse Gas Emissions calculation were revealed.
- Data quality was considered acceptable in meeting the principles as set out in ISO/CNS 14064-1:2006.
- The emission factor for electricity for the year 2019 is not published by Taiwan government so far, the emission factor used for electricity is 0.533 kilograms of Carbon Dioxide equivalent per kWh instead which may potentially result in different Greenhouse Gas Emission estimates.
